ORDER

The Director, Minority Welfare Department has submitted a proposal as per paper read above. The scheme is to guide students to choose right courses/colleges/career according to their taste/aptitude. Many students/youths under minority community will get a chance to bright up their career in different fields. 200 candidates will be selected for one programme according to the ratio 80:20 among Muslim and Christian students. 30% seats are reserved for girls and 40% for BPL students.

1. Eligibility Criteria:- Students of standard 10, +2/VHSE, Degree(2nd/Final year) are eligible for this programme. The students who got at least 60% mark in the examination written and result announced last, can apply for the programme, in their residing district only. 200 students will be selected for one programme.

2. Mode of selection:-

The application received in the minority sections in the District Collectorates will be scrutinized and the selection will be done on the basis of the prescribed criteria. On the receipt of more application the meritorious students will be selected. The programme will be conducted between the 2nd and 3rd term of the academic year.

In the current year's budget an amount of Rs.20 lakhs has been earmarked under the H/A.'2225-04-277-95' for the above scheme. The Director, Minority Welfare Department as per the letter read above has reported that the anticipated expenses for one programme will come to Rs.63,000/-.

Government have examined the proposal in detail and are pleased to accord Administrative Sanction for conducting the Career Guidance Programmes all over Kerala at a total cost of Rs.20 lakhs, with an estimated expenditure of Rs.63,000/- (Rupees sixty three thousand only) per programme. The expenditure will be met from the H/A.'2225-04-277-95' in the current year's budget.
