Minority Welfare Department – Scholarship scheme for minority students pursuing courses such as Chartered Accountancy (CA), Cost & Works Accountancy (ICWA) and Company Secretaryship (CS) (2014-15) - Administrative Sanction accorded - Orders issued.

ORDER

The Director, Minority Welfare Department has submitted a proposal as per letter read above, with the aim of providing scholarship to minority students pursuing courses of Chartered Accountancy (CA), Cost & Works Accountancy (ICWA) and Company Secretaryship (CS), which are not much opted courses at present, but having better career opportunities. An amount of Rs.180 lakh has been earmarked under the H/A. 2225-04-277-96 in the current years budget for the scheme.

The selection will be based on merit and income basis having 60% marks in B.Com/other Graduation. Students having annual income below 6 lakh are eligible for scholarship and preference will be given to BPL candidates. The reservation among Muslims and other minority communities is in the ratio 80:20 and 30% of seats will be reserved for girl students.

In case adequate number of students for Final examination have not applied, this will be given to candidates studying for CA/ICWA/CS(Inter). If adequate number of candidates are not available in a district, it will be distributed in other districts in proportion to the number of eligible candidates applied for the benefits in that district. The candidates has to submit the receipt of registration fee and tuition fee paid by them and the fee will be reimbursed to the bank account of the candidates by RTGS mode. The benefit of the scheme will be extended to 500 candidates each undergoing Final and Intermediate courses and 1000 candidates undergoing Foundation course.

The fund allocation of the scheme for total 2000 students is as follows:

* Scholarship to the students undergoing coaching for intermediate	= Rs.12,000x500students = Rs.60,00,000/-
* Scholarship to the students undergoing coaching for final	=Rs.12000x500students = Rs.60,00,000/-
* Foundation Course	=Rs.6000*1000students = Rs.60,00,000/-

Total = Rs.1,80,00,000/-

The Departmental Working Group Meeting held on 23.4.15, considered the proposal and approved the scheme.

In the circumstances Government have examined the proposal in detail and are pleased to accord Administrative Sanction for the Scholarship scheme for minority students pursuing courses of Chartered Accountancy (CA), Cost & Works Accountancy (ICWA) and Company

Secretaryship (CS), for an amount of Rs.180 lakh under the H/A. 2225-04-277-96 in the current years budget subject to the following conditions;

1. The scheme shall be implemented subject to the conditions specified in the plan write up 2015-16.
2. Proper follow –up and monitoring regarding placement of students shall be done.

The scholarship will be given to the eligible candidates on merit cum means basis @ Rs.12,000/- for Intermediate course, Rs.12,000/- for Final course and Rs.6000/- for Foundation course of CA/ICWA/CS. The number of scholarship for each course will be fixed in accordance with the number of eligible applications limiting the total amount to the current year's budget allocation (i.e, Rs.180 lakh).

The implementation of the scheme will be monitored by the Directorate of Minority Welfare, and minority section in the district collectorates.
